BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the EDUCATION DEVELOPMENT CENTER, NEW CAPITOL BUILDING, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2023 - 0025 re; Procurement of Medals for Outstanding Graduating Students in all Elementary and High Schools, Colleges and Universities with an ABC of P 487,500.00;


WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that CENTROID PRINTSHOP offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:






