**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE,
 DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING APPROVAL**

WHEREAS, the **CONG. SIMEON G. TORIBIO HOSPITAL, CARMEN, BOHOL**, of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement of goods under Purchase Requests No. - PHO - 2022 - 455 re: **PROCUREMENT OF MEDICAL/SURGICAL SUPPLIES** with an ABC of P 943,358.35

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **A.M.A PHARMA AND MEDICAL SUPPLIES TRADING** and **RGZI MEDICAL & LABORATORY SUPPLY** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Proposals.

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **A.M.A PHARMA AND MEDICAL SUPPLIES TRADING** and **RGZI MEDICAL & LABORATORY SUPPLY** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid **A.M.A PHARMA AND MEDICAL SUPPLIES TRADING** and **RGZI MEDICAL & LABORATORY SUPPLY** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**.

- b.) To recommend award to **A.M.A PHARMA AND MEDICAL SUPPLIES TRADING** in the amount of **(P 521,675.00)** and **RGZI MEDICAL & LABORATORY SUPPLY** in the amount of **(P 416,050.00)** for the delivery of goods under Negotiated Canvass No. - PHO - 2022 - 274.
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
