**WHEREAS**, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by **INTEGRATED SCIENTIFIC & INDUSTRIAL SUPPLY** the bidder declared as the **SINGLE CALCULATED BID**, successfully passed the Post Qualification process, thus the Committee now considered its bid as the **SINGLE CALCULATED and RESPONSIVE BID** for the said project;
