BAC RESOLUTION DECLARING LOWEST COMPLYING AND RESPONSIVE BID AND RECOMMENDING APPROVAL OF AWARD

BIDS AND AWARDS COMMITTEE

WHEREAS, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the posting of ADVERTISEMENT at PhilGEPS, PGB Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City for the Invitation to Apply for Eligibility and to Bid for the Project, hereunder described:

WHEREAS, during the holding of the competitive public bidding for the above procurement request, **TWO (2) BIDDERS**, bought the **BID DOCUMENT** in the actual conduct of public bidding namely;

GEMWEALTH CONSTRUCTION AND TRADING
NXTLVL WATER TECHNOLOGY INC.

WHEREAS, after the opening of bids, the bid proposal of the said bidder was found to be substantially complying;

WHEREAS, in the detailed evaluation of bids **GEMWEALTH CONSTRUCTION AND TRADING** was declared as the Lowest Calculated Bid as Read and was recommended for post qualification;

WHEREAS, during post qualification by the Technical Working Group, **GEMWEALTH CONSTRUCTION AND TRADING** failed to comply with the following documents:

1. *GEMWEALTH CONSTRUCTION AND TRADING failed for At least one (1) work of a nature and complexity equivalent to the Works generally in the last 10 years with at least 50% of the Estimated Project Cost (EPC) or PhP6,670,500.00 (Similar work shall refer to Construction of Saltwater Desalination for Potable Water)*
2. *GEMWEALTH CONSTRUCTION AND TRADING failed for List of Contractor's major and critical equipment units, which are owned and are supported by proof of ownership, which must meet the minimum requirement for the contract set in the Bid Data Sheet.*

WHEREAS, upon recommendation by the Technical Working Group and verification, validation and ascertaining of all statements made and documents submitted by the **GEMWEALTH CONSTRUCTION AND TRADING** the bidder declared as the **LOWEST CALCULATED BID**, did not passed the Post Qualification process, thus the Committee now considered its bid as **NON-COMPLYING** for the said project;

WHEREAS, upon the conduct of post qualification by the Technical Working Group to **NXTLVL WATER TECHNOLOGY INC.** as the 2nd Lowest Calculated Bid, including comparison of bids through arithmetical computation and discounted consideration, **NXTLVL WATER TECHNOLOGY INC.** met the financial, legal and technical components submitted for the said project and **successfully passed** the Post Qualification Process and upon recommendation by the Technical Working Group and after verification, validation and ascertaining of all statements made and documents submitted, thus, the Committee now considered its bid as the **Lowest Complying and Responsive Bid** for the said project;

NOW THEREFORE, We the members of the Bids and Awards Committee, hereby **RESOLVE**, as it is hereby **RESOLVED**:

- a) To declare **NXTLVL WATER TECHNOLOGY INC.** as the **LOWEST CALCULATED** and **RESPONSIVE BID** for **BRGY. HINGOTANAN WEST POTABLE WATER SYSTEM HINGOTANAN ISLAND, BIEN UNIDO, BOHOL**
Under Project Reference No. **PRDP-IB-R007-BOH-008-000-000-2018-AF2-F1**;
- b) To recommend award to **NXTLVL WATER TECHNOLOGY INC.** for the **BRGY. HINGOTANAN WEST POTABLE WATER SYSTEM HINGOTANAN ISLAND, BIEN UNIDO, BOHOL** in the contract amount of **₱ 12,732,543.92**;
- c) To recommend for the approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.






