

BAC Resolution Recommending the Use of Negotiated Procurement through Small Value, Declaring Lowest Calculated and Responsive Quotation and Recommending Approval

> RESOLUTION NO. 26-1024 Series of 2020

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION MANAGEMENT OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2020-0689, re; Procurement of Non-Inverter Aircondition Units with Installation, Freon as Cooling System for the use of PDDRMO Tarsier 117 Operations Center/ Headquarters in times of Pandemic, Camp Benido, Dao District, Tagbilaran City. with an ABC of P 205,576.00;
