BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE, NEW CAPITOL SITE, TAGBILARAN CITY of the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Purchase Requests No. 2023 - 0334 re; Procurement of various vehicle spare parts for the vehicles/ambulances with an ABC of P 181,990.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that TAGBILARAN CITY TYRE SALES & SERVICE CENTER offered the lowest price quotation among the suppliers as reflected in the Abstract of Bid Quotations;

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of TAGBILARAN CITY TYRE SALES & SERVICE CENTER including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its quotation TAGBILARAN CITY TYRE SALES & SERVICE CENTER has been found to be ELIGIBLE and its bid, RESPONSIVE;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare TAGBILARAN CITY TYRE SALES & SERVICE CENTER as the supplier with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for the **DELIVERY OF GOODS/SERVICES** under Negotiated Canvass No. 2023 - 0186;
- b.) To recommend award to TAGBILARAN CITY TYRE SALES & SERVICE CENTER for the delivery of goods/services under Negotiated Canvass No. 2023 - 0186 in the amount of P 181,498.00;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings.
