BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **PROVINCIAL HEALTH OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2024-062** re: **PROVISION OF ROOM ACCOMMODATION, MEALS AND SNACKS FOR THE ACTIVITY ON ENVIRONMENTAL SANITATION PROGRAM** with an ABC of **₱ 187,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **ARABELLE SUITES** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
