WHEREAS, the OFFICE OF THE PROVINCIAL AGRICULTURIST- CROPS/HVCDP of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2024-066 re: PROCUREMENT OF MEAL AND SNACKS FOR THE TRAININGS/SEMINARS/WORKSHOPS/CONSULTATIVE MEETINGS FOR MODELONG GULAYAN SA PAARALAN TWG MEETING with an ABC of ₱ 96,200.00;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:




