BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the <u>PROVINCIAL YOUTH DEVELOPMENT OFFICE</u> of the <u>PROVINCIAL GOVERNMENT OF BOHOL</u> made procurement under Purchase Request No. 2024-069 re: <u>PROVISION OF CATERING SERVICES TO BE USED FOR THE HANAS SPORTS CLINIC</u> with an ABC of **P 144,300.00**;
