BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **PROVINCIAL HEALTH OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2024-081** re: **PROCUREMENT OF MEAL AND SNACKS FOR THE USE OF ACTIVITY OF NUTRITION AND BSN PROGRAM**, with an ABC of **₱ 78,600.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **REYNAS THE HAVEN & GARDENS FOOD CATERING SERVICES INC** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
