WHEREAS, the PROVINCIAL HEALTH OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2024-081 re: PROCUREMENT OF MEAL AND SNACKS FOR THE USE OF ACTIVITY OF NUTRITION AND BSN PROGRAM, with an ABC of ₱ 78,600.00;
