BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the <u>PROVINCIAL YOUTH DEVELOPMENT OFFICE- YOUTH SECTION</u> of the <u>PROVINCIAL GOVERNMENT OF</u>
BOHOL made procurement under Purchase Request No. 2024-087 re: <u>PROVISION OF CATERING SERVICES AND</u>
ACCOMMODATION TO BE USED FOR THE ANNUAL YOUTH GOVERNANCE with an ABC of ₱ 328,600.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>JJ'S</u> <u>FOODLAND CORPORATION</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

- a). To declare that JJ'S FOODLAND CORPORATION as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the CATERING & ACCOMMODATION SERVICES under Negotiated Canvass No. 2024-084;
- b). To recommend award to <u>JJ'S FOODLAND CORPORATION</u> for the Catering Services of the aforementioned request in the amount of <u>P 327,980.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
