BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE- RESEARCH AND PLANNING DIV** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. 2024-117 re: **PROCUREMENT OF MEAL AND SNACKS FOR THE PARTICIPANTS OF THE CONDUCT OF INVENTORY, MAPPING AND GEOTAGGING OF CRITICAL FACILITIES AND LIFELINES** with an ABC of **₱ 384,000.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **REYNAS THE HAVEN AND GARDENS FOOD CATERING SERVICES INC.** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
