BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE- RESEARCH AND PLANNING DIV of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2024-117 re: PROCUREMENT OF MEAL AND SNACKS FOR THE PARTICIPANTS OF THE CONDUCT OF INVENTORY, MAPPING AND GEOTAGGING OF CRITICAL FACILITIES AND LIFELINES with an ABC of \$\mathbb{P}\$ 384,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that <u>REYNAS THE HAVEN AND GARDENS FOOD CATERING SERVICES INC.</u> offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED:

- a). To declare that <u>REYNAS THE HAVEN AND GARDENS FOOD CATERING SERVICES INC.</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE QUOTATION</u> for the <u>CATERING SERVICES</u> under Negotiated Canvass No. 2024-111;
- To recommend award to <u>REYNAS THE HAVEN AND GARDENS FOOD CATERING SERVICES INC.</u> for the Catering Services of the aforementioned request in the amount of <u>P 382,720.00</u>;
- c). To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
