BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the PROVINCIAL VETERINARIAN OFFICE of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No. 2024-131 re: PROVISION OF CATERING SERVICES FOR OPV ACTIVITIES with an ABC of ₱ 96,600.00;
