BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the **PROVINCIAL VETERINARIAN OFFICE** of the **PROVINCIAL GOVERNMENT OF BOHOL** made procurement under Purchase Request No. **2024-131** re: **PROVISION OF CATERING SERVICES FOR OPV ACTIVITIES** with an ABC of **₱ 96,600.00**;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement showed that **SEAFRONT SEPO GRILL AND RESTAURANT** offered the lowest price quotation among the suppliers as reflected in the Abstract of Bids Proposals;
