BAC Resolution Declaring LCRQ and Recommending Award

WHEREAS, the OFFICE OF THE PROVINCIAL VETERINARIAN of the PROVINCIAL GOVERNMENT OF BOHOL made procurement under Purchase Request No., 2024-154 re: PROVISION OF CATERING SERVICES FOR OPV ACTIVITIES with an ABC of ₱ 214,500.00;
