**WHEREAS**, the **PROVINCIAL GOVERNMENT OF BOHOL** caused the advertisement and posting of Invitation to Bid in the PHILGEPS Website, Provincial Government Website and at three (3) conspicuous places in the premises of the Provincial Capitol Complex, Tagbilaran City of the hereunder project:

**WHEREAS**, during the bid opening on **January 31, 2024**, **HJA MEDICAL SUPPLIES TRADING** and **PRIM E CONSTRUCTION SUPPLIES TRADING** submitted their bid proposals for the said procurement;
