



PROCUREMENT OF LABORATORY SUPPLIES

CONTRACT AGREEMENT

THIS AGREEMENT made the JUL 01 2024 2024 between the **PROVINCIAL GOVERNMENT OF BOHOL** (hereinafter called the "Entity") of the one part and **CORELAB DIAGNOSTICS MEDICAL SUPPLIES** of Zone-5 Poblacion, Opol, Misamis Oriental (hereinafter called the "Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services particularly **PROCUREMENT OF LABORATORY SUPPLIES FOR LOT NOS. 1 & 2** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Twenty Thousand Seven Hundred Fifty Pesos Only (P 20,750.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Supplier hereinafter referred to.

 - v. Bill of Quantities/Price Schedule
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

In consideration for the sum of **Twenty Thousand Seven Hundred Fifty Pesos Only (P 20,750.00)** or such other sums as may be ascertained, **CORELAB DIAGNOSTICS MEDICAL SUPPLIES** agrees to the delivery of goods/services under **Project Reference no. 2024-000071** the **PROCUREMENT OF LABORATORY SUPPLIES FOR LOT NOS. 1 & 2** in accordance with his/her/its Bid.

4. The **PROVINCIAL GOVERNMENT OF BOHOL** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

5. In consideration of the payments to be made by the Entity to the Supplier, as earlier mentioned, the Supplier hereby covenants with the Entity to implement and complete the services in conformity with the provisions of the Contract, the documents incorporated herein and the laws and regulations made integral parts hereof.

6. The Entity hereby covenants to pay the above-mentioned sum corresponding to the value of goods upon completion of delivery and acceptance in accordance with the prevailing accounting and auditing rules and regulations.
