**BAC RESOLUTION RECOMMENDING THE USE OF ALTERNATIVE MODE OF THROUGH DIRECT CONTRACTING, DECLARING SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL**

**WHEREAS**, the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Project Reference no. 2024-000086 re: PROCUREMENT OF OFFICE EQUIPMENT with an ABC of P 1,133,447.00;

**WHEREAS**, above requisitioned goods are sold/distributed/provided by GLOBAL COPIER TRADING, COPIER SOURCE ENTERPRISES, COPYLANDIA OFFICE SYSTEMS CORPORATION & PHILIPPINE DUPLICATORS, INC., Exclusive Dealer of the aforementioned brand of products;

**WHEREAS**, in view of the foregoing, it was granted approval by the Honorable Acting Governor to have the goods procured thru the **DIRECT CONTRACTING METHOD OF PROCUREMENT**, and subsequently requested the BIDS AND AWARDS COMMITTEE to recommend the method of procurement it resorted to, as well as to confer recommendation of award to the Responsive Bidder;

**WHEREAS**, the **BIDS AND AWARDS COMMITTEE**, upon a profound deliberation on the matter presented, with due consideration that the above requisitioned goods can be acquired thru direct purchase as attested by the PMO/End User, duly accorded the Request with favorable action;
