SUPPLY AND INSTALLATION OF PROTECTION AND SAFETY DEVICES COMPATIBLE WITH THE THREE (3) ELEVATORS

CONTRACT AGREEMENT

No: 2024-00303

THIS AGREEMENT made the 13 SEP 2024 day of 2024 between the **PROVINCIAL GOVERNMENT OF BOHOL** (hereinafter called the "Entity") of the one part and **EVOLIFTECH ELEVATOR AND ESCALATOR SERVICES** of Blk 1 Lot 39 St. Michael St., BF Topman Homes I, Brgy. Molino II, Bacoor Cavite, Philippines (hereinafter called the "Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services particularly **SUPPLY AND INSTALLATION OF PROTECTION AND SAFETY DEVICES COMPATIBLE WITH THE THREE (3) ELEVATORS** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION EIGHT HUNDRED THOUSAND PESOS ONLY (P 1,800,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Supplier hereinafter referred to.
2. The following documents as required by 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements
 - ii. Technical Specification
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - v. Bill of Quantities/Price Schedule

ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **ONE MILLION EIGHT HUNDRED THOUSAND PESOS ONLY (P 1,800,000.00)** or such other sums as may be ascertained, **EVOLIFTECH ELEVATOR AND ESCALATOR SERVICES** agrees to the delivery of goods/services under the **SUPPLY AND INSTALLATION OF PROTECTION AND SAFETY DEVICES COMPATIBLE WITH THE THREE (3) ELEVATORS** in accordance with his/her/its Bid.

4. The **PROVINCIAL GOVERNMENT OF BOHOL** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

5. In consideration of the payments to be made by the Entity to the Supplier, as earlier mentioned, the Supplier hereby covenants with the Entity to implement and complete the services in conformity with the provisions of the Contract, the documents incorporated herein and the laws and regulations made integral parts hereof.

6. The Entity hereby covenants to pay the total contract price upon completion of delivery.


