CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of 14 OCT 2024 2024 between the **PROVINCIAL GOVERNMENT OF BOHOL** (hereinafter called the "Entity") of the one part and **DAVID RAMOS IT SOLUTIONS** of Angelico, Poblacion. Liloan, Cebu (hereinafter called the "Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods particularly **PROCUREMENT OF ARCHIVING SYSTEM, CAMERAS/CAMERA SYSTEMS AND VARIOUS I.T EQUIPMENT & DEVICES** and has accepted a Bid by the Supplier for the supply of those goods under **PROJECT REFERENCE NO. 2024 -000203** for Lot No. 1 in the sum of **THREE MILLION ONE HUNDRED FIFTY-THREE THOUSAND PESOS ONLY (P 3,153,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Supplier hereinafter referred to.

2. The following documents as required by 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements
 - ii. Technical Specification
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - v. Bill of Quantities/Price Schedule

ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

3. In consideration for the sum of **THREE MILLION ONE HUNDRED FIFTY-THREE THOUSAND PESOS ONLY (P 3,153,000.00)** or such other sums as may be ascertained, **DAVID RAMOS IT SOLUTIONS** agrees to the delivery of goods under the **PROJECT REFERENCE NO. 2024 - 000203, PROCUREMENT OF ARCHIVING SYSTEM, CAMERAS/CAMERA SYSTEMS AND VARIOUS I.T EQUIPMENT & DEVICES** (for lot no. 1) in accordance with his/her/its Bid.

4. The **PROVINCIAL GOVERNMENT OF BOHOL** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

5. In consideration of the payments to be made by the Entity to the Supplier, as earlier mentioned, the Supplier hereby covenants with the Entity to implement and complete the services in conformity with the provisions of the Contract, the documents incorporated herein and the laws and regulations made integral parts hereof.

6. The Entity hereby covenants to pay the above-mentioned amount in upon completion of delivery corresponding to the value of goods/services and accepted in accordance with the prevailing accounting rules and regulations.

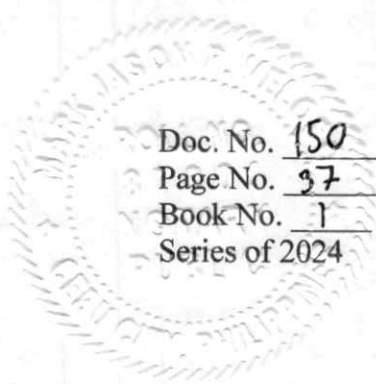
