WHEREAS, during the bid opening on June 19, 2024, LEZAR TRADING dropped its bid proposal for the said procurement;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby **RESOLVED:**




b) To recommend for the approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings.
