



CONTRACT AGREEMENT No. 2024-00415

This Contract Agreement is entered into by and between:

PROCURING ENTITY: The PROVINCIAL GOVERNMENT OF BOHOL, a local government of the Republic of the Philippines, with office address in Tagbilaran City, Bohol; and

SUPPLIER: LEZAR TRADING, with office address at Poblacion Sur, Carmen, Bohol.

WITNESSETH

WHEREAS, the Procuring Entity invited Bids for the following:

PROCUREMENT OF AGRICULTURAL SUPPLIES for Lot Nos.1,4,5,6 & 7

Approved Budget for the Contract (ABC): P 2,447,600.00

End User: Office of the Provincial Veterinarian

WHEREAS, after observing the applicable, relevant, and pertinent provisions of R.A. 9184, the Procuring Entity accepted the bid of the Supplier and awarded the contract to the Supplier with a bid in the sum of TWO MILLION FOUR HUNDRED THIRTEEN THOUSAND SIX HUNDRED FORTY-TWO PESOS ONLY (P 2,413,642.00), hereinafter referred to as the "Contract Price."

NOW, THEREFORE, with the intent to perform their respective obligations pursuant to the foregoing procurement, the parties hereby agree and stipulate:

 - Schedule of Requirements;

 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;

- OBLIGATION TO PAY. The Procuring Entity agrees to pay the above-mentioned sum in accordance with the terms of the bid and auditing rules and regulation;
- SPECIAL CONDITIONS (if applicable). The parties shall observe special conditions in the delivery or performance of the goods or services subject of this contract if so stipulated herein, otherwise, the usual conditions apply.
