BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD

WHEREAS, the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under 2024 - 000292 re: PROCUREMENT OF APPLIANCES with an ABC of P 173,000.00;

WHEREAS, quotation were requested and received from our three (3) supplier's of known qualifications, PARK AVENUE GENERAL MERCHANDISE, BOHOL QUALITY CORPORATION and PRIM E CONSTRUCTION SUPPLIES TRADING, canvass of prices done in the course of the Negotiated Method of Procurement thru Small Value Procurement showed that BOHOL QUALITY CORPORATION offered the responsive quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>BOHOL QUALITY CORPORATION</u>, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>BOHOL QUALITY CORPORATION</u> has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- b.) To recommend award to <u>BOHOL QUALITY CORPORATION</u> for the delivery of goods under <u>PROJECT REFERENCE NO. 2024 000292</u>, <u>PROCUREMENT OF APPLIANCES</u>, in the amount of <u>ONE HUNDRED TWENTY-SEVEN THOUSAND SIX HUNDRED FORTY-SIX PESOS ONLY (P 127,646.00);</u>
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
