BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT (EMERGENCY CASES),
DECLARING SINGLE CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING AWARD

WHEREAS, the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Project Reference No. 2024-000310 re: PROCUREMENT OF LABORATORY SUPPLIES with an ABC of P 3,124,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement – Emergency Cases showed that <u>CEBU FAR EASTERN DRUG, INC.</u> offered the single price quotation as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.2 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>CEBU FAR EASTERN DRUG, INC.</u>, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>CEBU FAR EASTERN DRUG, INC.</u> has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
