BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING APPROVAL

WHEREAS, the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods/services/civil works under Project Reference No. 2024-000459 re: PROCUREMENT OF ICT EQUIPMENT & DEVICES with an ABC of P 945,002.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Small Value Procurement showed that <u>STRATEGIC SYNERGY INC.</u>, <u>STELLAR AUTOMATION TECHNOLOGY INC.</u> AND <u>MIKKELER CONSUMER GOODS TRADING</u> offered the responsive quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <u>MIKKELER CONSUMER GOODS TRADING</u>, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, <u>MIKKELER CONSUMER GOODS TRADING</u> has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare <u>MIKKELER CONSUMER GOODS TRADING</u> as the bidder with the <u>LOWEST CALCULATED AND RESPONSIVE QUOTATION</u> for Lot Nos.1-6 for the <u>DELIVERY OF GOODS</u> under <u>Project Reference No. 2024-000459</u>; while Lot Nos. 7 & 8 are recommended for Recanvassing.
- b.) To recommend award to <u>MIKKELER CONSUMER GOODS TRADING</u> for the delivery of goods under <u>Project Reference No. 2024-000459</u>, in the amount of <u>EIGHT HUNDRED</u> <u>TEN THOUSAND NINE HUNDRED PESOS ONLY(P 810,900.00)</u>;
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
