**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD**

**WHEREAS**, the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under **2024 - 000490** re: **PROCUREMENT OF COOKING GAS, FOOD STUFF AND PERSONAL CARE PRODUCTS** with an ABC of **P 244,830.00**;

**WHEREAS**, quotation were requested and received from our three (3) supplier's, **ALTURAS SUPERMARKET CORPORATION, BOHOL QUALITY CORPORATION** and **PRIM E CONSTRUCTION SUPPLIES TRADING**, canvass of prices done in the course of the Negotiated Method of Procurement thru Small Value Procurement showed that **PRIM E CONSTRUCTION SUPPLIES TRADING** offered the responsive quotation among the suppliers as reflected in the Abstract of Bid Proposals,

**WHEREAS**, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **PRIM E CONSTRUCTION SUPPLIES TRADING**, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, **PRIM E CONSTRUCTION SUPPLIES TRADING** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED**:

- a.) To declare **PRIM E CONSTRUCTION SUPPLIES TRADING** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for Lot Nos. 1 & 2 the **DELIVERY OF GOODS** under **PROJECT REEFERENCE NO. 2024 - 000490, PROCUREMENT OF COOKING GAS, FOOD STUFF AND PERSONAL CARE PRODUCTS**;
- b.) To recommend award to **PRIM E CONSTRUCTION SUPPLIES TRADING** for the delivery of goods under **PROJECT REEFERENCE NO. 2024 - 000490, PROCUREMENT OF COOKING GAS, FOOD STUFF AND PERSONAL CARE PRODUCTS**, in the amount of **TWO HUNDRED FORTY-FOUR THOUSAND SIX HUNDRED SIXTY-ONE PESOS ONLY (P 244,661.00 )**;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
