WHEREAS, the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under 2024 - 000490 re: PROCUREMENT OF COOKING GAS, FOOD STUFF AND PERSONAL CARE PRODUCTS with an ABC of P 244,830.00;

WHEREAS, quotation were requested and received from our three (3) supplier's, <u>ALTURAS SUPERMARKET CORPORATION</u>, <u>BOHOL QUALITY CORPORATION</u> and <u>PRIM E CONSTRUCTION</u> <u>SUPPLIES TRADING</u>, canvass of prices done in the course of the Negotiated Method of Procurement thru Small Value Procurement showed that <u>PRIM E CONSTRUCTION SUPPLIES TRADING</u> offered the responsive quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of <a href="PRIM E CONSTRUCTION SUPPLIES">PRIM E CONSTRUCTION SUPPLIES</a>
