**BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD**

**WHEREAS**, the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods/services/civil works under 2024 - 000509 re: PROCUREMENT OF MEDICAL AND DENTAL DEVICES AND EQUIPMENT with an ABC of **P 267,500.00;**

**WHEREAS**, quotation were requested and received from our four (4) supplier's, AMI EQUIPMENT SERVICES AND SOLUTIONS, INC., QUANTUM HEALTHCARE PHILIPPINES, INC., 5 JP'S CORPORATION and PHIL-ORIENT PHARMA MEDICAL SUPPLIES TRADING, canvass of prices done in the course of the Negotiated Method of Procurement thru Small Value Procurement showed that QUANTUM HEALTHCARE PHILIPPINES, INC., 5 JP'S CORPORATION offered the responsive quotation among the suppliers as reflected in the Abstract of Bid Proposals,

**WHEREAS**, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of QUANTUM HEALTHCARE PHILIPPINES, INC., 5 JP'S CORPORATION, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, QUANTUM HEALTHCARE PHILIPPINES, INC., 5 JP'S CORPORATION has been found to be **ELIGIBLE** and its bid, **RESPONSIVE;**

**NOW, THEREFORE**, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED:**

To recommend award to 5 JP'S CORPORATION in the amount of **ONE HUDNRED SIX THOUSAND EIGHT HUNDRED PESOS ONLY(P 106,800.00)** and QUANTUM HEALTHCARE PHILIPPINES, INC. in the amount of **ONE HUDNRED SIXTY THOUSAND FOR HUNDRED TWENTY-NINE PESOS AND 92/100 ONLY (P 160,429.92)** for the delivery of goods under PROJECT REFERENCE NO. 2024 -000509, PROCUREMENT OF MEDICAL AND DENTAL DEVICES AND EQUIPMENT.
