WHEREAS, the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods/services/civil works under 2024 - 000509 re: PROCUREMENT OF MEDICAL AND DENTAL DEVICES AND EQUIPMENT with an ABC of P 267,500.00;

WHEREAS, quotation were requested and received from our four (4) supplier's, <u>AMI EQUIPMENT SERVICES AND SOLUTIONS, INC.</u>, <u>QUANTUM HEALTHCARE PHILIPPINES, INC.</u>, <u>5 JP'S CORPORATION</u> and <u>PHIL-ORIENT PHARMA MEDICAL SUPPLIES TRADING</u>, canvass of prices done in the course of the Negotiated Method of Procurement thru Small Value Procurement showed that <u>QUANTUM HEALTHCARE PHILIPPINES, INC.</u>, <u>5 JP'S CORPORATION</u> offered the responsive quotation among the suppliers as reflected in the Abstract of Bid Proposals,

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:


