BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD

WHEREAS, the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Project Reference No.2024-000598 re: **PROCUREMENT OF VEHICLES SPARE PARTS AND ACCESSORIES** with an ABC of **P 421,961.75;**

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Small Value Procurement showed that **JETS MARKETING, CARE AUTOHAUS, TAGBILARAN TIRE SUPPLY AND SUBIC GS AUTO INC./HINO NAGA CEBU** offered the responsive quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **SUBIC GS AUTO INC./HINO NAGA CEBU, TAGBILARAN TIRE SUPPLY AND CARE AUTOHAUS**, including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, **SUBIC GS AUTO INC./HINO NAGA CEBU, TAGBILARAN TIRE SUPPLY AND CARE AUTOHAUS** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE;**

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby **RESOLVE**, as it hereby **RESOLVED:**

- a.) To declare **SUBIC GS AUTO INC./HINO NAGA CEBU** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for Lot Nos.1,3&5 (item nos.2,3&19), **TAGBILARAN TIRE SUPPLY** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for Lot Nos.2&5 (item nos.1,6-13,15,16&18) and **CARE AUTOHAUS** as the bidder with the **LOWEST CALCULATED AND RESPONSIVE QUOTATION** for Lot Nos.4&5 (item nos.4,5,14&17) for the **DELIVERY OF GOODS** under Project Reference No.2024-000598;
- b.) To recommend award to **SUBIC GS AUTO INC./HINO NAGA CEBU** in the amount of **FIFTY-FIVE THOUSAND NINE HUNDRED THREE PESOS ONLY(P 55,903.00)**, **TAGBILARAN TIRE SUPPLY** in the amount of **SIXTY-FIVE THOUSAND EIGHT HUNDRED THIRTY PESOS ONLY(P 65,830.00)** and **CARE AUTOHAUS** in the amount of **TWO HUNDRED EIGHTY-FOUR THOUSAND NINE HUNDRED TWENTY-NINE PESOS ONLY(P 284,929.00)** for the delivery of goods under Project Reference No.2024-000598;
- c.) To recommend for approval by the **HONORABLE GOVERNOR** of the **PROVINCIAL GOVERNMENT OF BOHOL** the foregoing findings
