BAC RESOLUTION RECOMMENDING THE USE OF NEGOTIATED PROCUREMENT THROUGH SMALL VALUE, DECLARING LOWEST CALCULATED AND RESPOSIVE QUOTATION AND RECOMMENDING AWARD

WHEREAS, the PROVINCIAL GOVERNMENT OF BOHOL made procurement of goods under Project Reference No. 2024 - 000741 re: PROCUREMENT OF COOKING GAS, FOOD STUFF, AND PERSONAL CARE PRODUCTS with an ABC of P 472,000.00;

WHEREAS, canvass of prices done in the course of the Negotiated Method of Procurement thru Small Value Procurement showed that PRIM E CONSTRUCTION SUPPLIES TRADING, ALTURAS SUPERMARKET CORPORATION, AND BOHOL QUALITY CORPORATION offered the responsive quotation among the suppliers as reflected in the Abstract of Bid Proposals,

WHEREAS, under Section 53.9 of the IRR of R.A. 9184 and upon careful examination, validation and verification of the accreditation and other pertinent documents of **PRIM E CONSTRUCTION SUPPLIES TRADING** including the price quotation offered, to determine its eligibility to transact business with the Provincial Government and the responsiveness of its bid, **PRIM E CONSTRUCTION SUPPLIES TRADING** has been found to be **ELIGIBLE** and its bid, **RESPONSIVE**;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE, as it hereby RESOLVED:

- a.) To declare PRIM E CONSTRUCTION SUPPLIES TRADING as the bidder with the LOWEST CALCULATED AND RESPONSIVE QUOTATION for the DELIVERY OF GOODS under Project Reference No. 2024 000741 for the Procurement of Cooking Gas, Food Stuff, and Personal Care Products;
- b.) To recommend award to PRIM E CONSTRUCTION SUPPLIES TRADING for the delivery of goods under Project Reference No. 2024 000741 for the Procurement of Cooking GAS, Food Stuff, and Personal Care Products; , in the amount of FOUR HUNDRED SEVENTY ONE THOUSAND FOUR HUNDRED PESOS ONLY P 471,400.00);
- c.) To recommend for approval by the HONORABLE GOVERNOR of the PROVINCIAL GOVERNMENT OF BOHOL the foregoing findings
